1. Hi Weronika, thanks for your interest in this interview. How are you, and what's new?

I am doing very well, so thank you for asking. As far as what's new, I am currently working on a few translations of original National Socialist material. Among these translations are: *The "Nazi" Bible*¹, *Bolshevism in the Bible*, and *The Memoirs of Satan*. I am also planning to expand my original book, *Black Nazis! A Study of Racial Ambivalence in Nazi Germany's Military Establishment*, in a fourth edition, which will be the final edition of the book. The first and second editions are completely sold out. *Black Nazis* is currently in its third edition and will remain available in hardcover format until the release of the fourth and final edition. I am also working on a research piece that will be included as a comprehensive "Part One" introduction to one of my more current books, *Judah-Antichrist: A Look Behind the Scenes of World Politics*. This book is a Third Reich original publication written by Father Gaston Ritter (my translation is based on the third edition). What sparked my interest in this book was the author's mention of the "Jewish Exilarch" and the "Council of 300".² I was unfamiliar with either until I read about them in this book.

The author's proposition is that the Jewish Messiah will be the Antichrist. Upon proving the validity of *The Protocols of the Elders of Zion*, the author cites *The Protocols* specifically as his supporting evidence. Of course, while the Jews collectively harp on *The Protocols* as an "antisemitic forgery," they never mention the bizarre details surrounding the Bern Trial, which supposedly discredited the document. However, one look at OpenAI, Anthropic, Flock cameras, Meta glasses, data centers, humanoid robots, Monsanto's glyphosate³, the Covid forced vaccination campaign, the World Economic Forum, Agenda 2030, AIPAC, the opioid crisis, etc., and one has more than enough evidence to promote *The Protocols* as legitimate. Jewish families and Jewish individuals are at the heart of every one of these evils in the world today. Every. Single. One. They are the drivers, the spearheads, the innovators. Is this just coincidence? The Jews will claim so, but this is typical Jewish gaslighting of non-Jews to keep us deaf, dumb, and blind to their true agenda: a Jewish world dictatorship. AI will be their most effective tool in achieving this goal. It's a tool that they have never had before and which will wreak deliberate, systematic havoc upon the non-Jewish world until the Jews step in and "fix" everything.

As you are likely aware, the Jews have a fixation on "repairing the world." If readers have not heard of this before, I would invite them to investigate the "*tikkun olam*" phenomenon thoroughly. "*Tikkun olam...first appeared in the Talmud, rabbinical commentaries compiled during the 1st millennium CE.*" The Jewish school, Brandeis University, discusses this "*tikkun olam*" complex at length.⁴ It is perhaps the main reason why Jews are so dangerous. If the

average person does not think that the Jews can play both sides of any given coin for their own collective benefit (*i.e.*, elevating their own interests above the interests of all others), then that person is woefully naïve. The Nazis could not hold a candle to the racism and exclusivity of the world's Jewish collective. Indeed, the Jews have no intention of imposing their "social justice" ideas in Israel, which, as you and your readers already know, is shamelessly committing genocide and engaging in terrorism in Gaza and the West Bank.⁵ The occasional Jewish individual or Jewish small potato organization will speak out against Jewry's deliberate, systematic mutilation and extermination of Palestinian Arabs, but these individuals and groups seldom put their money where their mouth is. Their words are nothing more than 'spit in the wind'. They are meaningless and they know it. Not one of them truly opposes the Jewish state. Not one. The overwhelming majority of Jews worldwide – whether they identify as ethnic Jews, religious Jews, atheist Jews, nationalist Jews, racial Jews, identitarian Jews, liberal Jews, or right-wing Jews – support the Jewish ethnostate of Israel. As such, it should come as no surprise that fifty communal Jewish groups have declared that "*Zionism is a part of Jewish identity*."⁶ Very bold, to say the least. This is equivalent to Germans proudly declaring, "*National Socialism is a part of German identity*." What's more, *thousands* of non-Zionist, non-Israeli Jews have signed a Gaza-genocide denial letter.⁷ The Jews themselves are holocaust deniers.

Approximately 46% of the world's Jewish population lives in Israel, where the vast majority identify as Zionist and support the state's existence.⁸ According to US polls, 85% to 92% of Jews agree that Israel has the right to exist as a *Jewish* state, and roughly 70% feel emotionally attached to it.⁹ Anti-Zionist Jews constitute a quiet, insignificant global minority.¹⁰ Rachel Corrie, a non-Arab American girl of European descent, gave her life for Palestinian Arabs. That is an individual who truly cared about the Arabs and even died for them. She was murdered by a Jewish soldier in 2003 while trying to prevent the Israeli army from destroying homes in the Gaza Strip.¹¹

Fact is, Jewishness is Zionism and Zionism is Jewishness. They are synonymous. This is why Macklemore was removed from Ed Sheeran's tour in September 2026 after he spoke out in behalf of Palestinians during two US concerts. Do people honestly think that the state of Israel or some Israeli had this American musician cancelled by American venues? Or will people come to realize that an American, who identifies as an ethnic Jew, is the one who got

Macklemore cancelled? The Jewish multi-billionaire, Robert Kraft¹², personally cancelled Macklemore by blackmailing Sheeran. According to Macklemore, “*Ed told me that Kraft said I would not be allowed to perform in his stadium. Ed also told me that **Kraft** had rallied some of the **other stadium owners** and **collectively** they gave him an ultimatum: if Macklemore stays on the tour, you will not be allowed to play in our venues.*”¹³ Kraft, who owns the Gillette Stadium in Massachusetts, said he banned Macklemore because the venue would not “*provide a platform for hate speech.*”¹⁴ Apparently, speaking out against war crimes, genocide, and ethnic cleansing is “*hate speech,*” unless we are talking about the Nazis. Then, “*it’s the truth, the whole truth, and nothing but the truth, so help [us] God.*” The ethnic Jewish singer Pink, who is not Zionist or Israeli but American, decided to flap off at the mouth, condemning Macklemore and inadvertently declaring her own Jewish supremacy. “*She emphasized that she is ‘standing up for my own people’ as a **Jewish** mother.*”¹⁵ She isn’t an American; she’s a Jew and she is very proud of this. We could justly call her a racial supremacist for such talk – “Jew pride worldwide.” It isn’t rocket science, people. Diaspora Jews act just like Israelis, only they act like Israelis everywhere but in Israel.

Rabbi Stephen S. Wise was a master at supporting Jewish self-determination and sovereignty in the form of Zionism, whilst pushing Liberal “DEI”-style ideology and policies outside of the Jewish ethnostate. His primary target was America. This is why it is fully acceptable for AIPAC to lobby US politicians today, directing tens of billions of American taxpayers’ dollars to Israel and Jewish interests annually, but it is completely unacceptable – impossible even – for a US lobby to achieve the same *vis-à-vis* the Jewish Knesset. Where is the American lobby in Israel? Where is the German lobby in Israel? Where is the Polish lobby in Israel? Point made and hopefully taken.

Jews are the most supremacist group of people in the world. They always have been, beginning with their outrageous “Chosen People” drivel. (Though, now they are unabashedly rearing their *racist* heads.¹⁶) Hence, their relentless campaign to promote and spread the idea that *their* demon god, Yahweh-Moloch, is the god of the entire world. In one word: monotheism. This is one reason why I find the Dangoor clan so interesting. The Sir Naim Dangoor Centre for Universal Monotheism is dedicated to the following: “*The main goal of the program was to cultivate real peace and understanding through truth, ethics, and action of the broad common ground shared by the major monotheistic religions: Judaism, Christianity and Islam. Later, the program’s goal expended [sic] and were defined as to open horizons to learn more about other religions, and to serve as a bridge to East Asian beliefs and traditions.*” The Dangoors are sniffing the wind and noticing that the future belongs to China, not Europe and America. Hence, the former Jewish Exilarch’s desire to nurture relations with the Asian countries. “*To promote cultural exchange and dialogue, the Centre expanded its activities and programming to Asia, with a particular emphasis on **China, India,***

Japan, Korea, Southeast Asia, as well as the Balkan region, primarily in Bulgaria and North Macedonia as well as Greece and Kosovo. This expansion involved establishing academic agreements with renowned universities and research centers in these regions, facilitating the exchange of scholars and students, organizing joint workshops and educational visits, conducting summer seminars, and providing teacher training on contemporary Israel Studies.”¹⁷

Coming back to the Jewish Exilarch and the Council of 300, I figured out the identities of these people. The current Jewish Exilarch is David Dangoor. As written in the introduction to my book *Judah-Antichrist*, “[Here’s the] Dangoor family tree [for the] last 4 generations:

- David Dangoor – current Exilarch – “Philanthropist”;
- Naim Dangoor – re-established the Exilarchate for the head of his foundation “The Exilarch Foundation” (publicly);
- Eliahou Dangoor – Largest printer of Arabic books in the world – provided textbooks to almost all Arabic-speaking countries;
- Hakim Ezra Dangoor – Chief Rabbi (Exilarch unofficially) of Baghdad.

“I can safely say that these four men have held power continually over the last 200 years, and more than likely [for] the 700 years prior [to] the removal of the [E]xilarch.

After reading the research of Erich Ludendorff, I believe the ‘Three Wise Men’ mentioned by Father Ritter are: Chaim Weizmann (1874–1952), Rabbi Stephen Samuel Wise (1874–1949), and Vladimir “Ze’ev” Jabotinsky (1880–1940). I will only elaborate a little bit for the sake of conciseness, but readers may consult my *Judah-Antichrist* book for more details on the Jewish Exilarchate, their alleged ‘Babylonian’ foundation, and their powerbrokers.

The ‘Council of 300’ consists of Jewish powerbrokers within the Masonic Order of B’nai B’rith. Today, this order chiefly operates behind the front known as the Anti-Defamation League (ADL), headquartered in America. I will quote briefly from the research of Erich Ludendorff, since his evidence is so damning to the Jewish collective and their agenda.

In his book, *The Destruction of Freemasonry Through the Revelation of Its Secrets* (originally published in German in 1927), Ludendorff writes:

*The independent Order B’nai B’rith, this means Sons of the Covenant...is the leading Jewish Order of the whole world, thus also in Germany. It was founded in the United States in 1843, is scattered over the entire world and practices its influence in all Jewish organizations. Among its members are the **well-known leading “300”, forming simultaneously the Jewish “General Staff”**; it is a **ruthless representative of the Jewish racial folk-community and the Jewish-capitalistic thought for world-rulership**, supervising the **political activities** of the States and **all influential parties**.*

Leading Jews of the whole world are its members, also those who during the (first) world war were conspicuously active everywhere, not least in Berlin, but especially during the (Communist) Revolution in Russia, Germany and Austro-Hungary... The administration of the Order is in New York; Germany is its 8th Province, Berlin the Seat of the Grand Masters. The German Grand-Lodge-Day has acknowledged the Order in 1906 as a "righteous and perfect" Lodge...

The Freemason-Pope A. Pike, who presided over the highest freemasonic authority, the highest council of Charleston, has explicitly confirmed them on September 12, 1874 after agreement with the B'nai B'rith Order.

2. The "Humanitarian" Grand Lodges

Any racial concept is omitted in these Lodges. They admit Germans and Jews and, of course, also Jewish members of the previously mentioned Jewish Lodges. The concept "Humanitas" as a characteristic essence of every Freemasonry demands per se the aloofness from all that "which keeps humanity" or "humaneness" divided, that is, "all religiously churchlike, political and fatherlandish" affairs, substituting this for the attainment of a racial melting-pot, of course, subjected to the sovereignty of the Jewish people, whose own racial individuality may not be infringed upon, but must be strengthened for "a glorious future", as the Prussian Minister of Culture so clearly expressed in his speech December 15, 1926, as already mentioned, and substantiated in the establishment of the League of Nations in Geneva, whose meetings, according to the **Zionist Leader Chaim Weizmann, are to be held later in Jerusalem, the future capital city of the Jewish "World-Empire."**

As you may know, US President Donald Trump officially recognized Jerusalem as the capital of Israel on December 6, 2017.¹⁸ And as we encountered previously with Rabbi Stephen S. Wise, non-Jews must be a "melting pot" while the Jews remain as pure and aloof as possible. Wise was quite the oxymoron, since he simultaneously promoted social justice *and* Zionism, an impossible position if one is being sincere about either, or both. He was nothing more than a Jewish hypocrite who did what he had to do to legitimize the theft of native land in the Middle East, and secure the interests of American Jews against all other ethnic groups competing for finite resources and influence in the US at the time. It is as simple as that. Social justice translates to Jewish security in non-Jewish communities and countries. They cloak their self-interest in the guise of civil rights and progressivism. Dr. Kevin Macdonald, of whom you are likely aware, has written extensively on this phenomenon (see *Separation and Its Discontents* and *Culture of Critique*, for example).

Publicly engaged rabbis and a Judaism committed to social justice and Zionism — these are the legacies of Rabbi Stephen S. Wise.

Though little known now, Wise was one of the most prominent rabbis in the United States in the first half of the 20th century and had a profound influence on shaping the political liberalism practiced by American Jews today.

In her new book, We Shall Build Anew: Stephen S. Wise, the Jewish Institute of Religion, and the Reinvention of American Liberal Judaism, associate professor of the

practice Shirley Idelson credits Wise with imbuing American Judaism, the Reform movement especially, with three core values:

- **Tikkun olam** (repairing the world, though Wise did not use this term).
- **Zionism** and support for the state of Israel.
- **Klal Yisrael**, a belief in the kinship and common destiny of the Jewish people (“all of Israel” in Hebrew).

Bullet point three should come as a wake-up call to anyone who still believes that Jewishness/Judaism and Zionism are distinguishable. They are not. All Jews are Zionists and all Zionists are Jews. All Jews, regardless of their specific political or religious inclination, work for Jewish interests, whether overtly or covertly, whether via inaction or direct action. At the heart of it: what’s in it for me, *as a Jew*? How does it benefit the *Jewish* community? How does it benefit *Jewish* political movements and social interests?

Wise worked closely with Louis Brandeis [Jew] to rally American support for Zionism, advocated for women’s suffrage and the rights of labor, and helped found the National Association for the Advancement of Colored People (NAACP). In the 1930s, he became one of the earliest and most outspoken American Jewish leaders to demand that the U.S. government confront Hitler and aid the Jews...

In her book, Idelson, the Leon A. Jick Director of the Hornstein Program in Jewish Professional Leadership, focuses on the Jewish Institute of Religion (JIR), a pluralistic seminary Wise founded in 1922 to train a new generation of rabbis. Based in New York, JIR trained nearly 200 rabbis, many outspoken community leaders and political activists, before it merged in 1950 with Hebrew Union College.¹⁹

As we can see, Jews are all about civil rights, feminism, women’s rights, universal suffrage, abortion, and all the social justice things – all the things – *only* if it benefits the Jewish collective. As for abortion and the genocide in Gaza, those are ritual sacrifices to the Jewish god, Moloch. If you are interested in learning more about the true identity of Yahweh, I encourage you to read my book, *Moloch-Yahweh: The Circumcised Moses*.

2. Please introduce yourself to everyone who doesn’t know you or hasn’t read your writings yet!

Of course! I earned my master’s degree in Military History from Norwich University. I have been researching the Third Reich since about 2001 or so. My focus is the complexity of racial dynamics in the Third Reich, but more recently, I have become interested in the satanic/occult origins of Judaism, specifically from a Third Reich perspective. The three books that fomented my interest in this particular subject matter include: *Judaism in the Shadow of the Antichrist*, *The Circumcised Moses*, and *The Six-Pointed Star*. Each one of these books introduced ideas with which I was not too familiar. I am now very interested in understanding the true “identity” of Yahweh, which Wilhelm Matthiesen effectively argues is Moloch. I am likewise interested in the origins of the Jewish symbol, the so-called “*Star of David*.” According to Jewish author O.J. Graham, it is not a star at all and it has nothing to do with King David. Instead, it is a hexagram and has everything to do with King Solomon and his worship of Moloch and Baal. King Solomon built an altar for the goddess Ashteroth, and he

also practiced Moloch rituals. The six-pointed star thus became the “*Seal of Solomon*.” Solomon never repented of his idolatry, and in fact the hexagram was engraved on the Seal of Solomon “*as a sign of his dominion over the demons*.” And then there’s the aforementioned *Judah-Antichrist* book, which mentions the Jewish Exilarch. I had to delve deep to untangle who he was referring to, but as you encountered earlier in our interview, I figured it out. The Jewish Exilarch was initially the leader of the Jewish people during the Babylonian Exile. He was (allegedly) the direct descendent of King David who led the Jews out of Babylon and on into Persia, where they settled for quite some time. (The Iraqi Jewish families mentioned previously – the Dangoors, the Sassoons, the Kadoories, and possibly the Rothschilds – are all allegedly direct descendants of King David, as well.) From there, these Babylonian Jews migrated to Eastern Europe and mixed with the Ashina and Khazar peoples, effectively becoming the Ashkenazim of today. I am simplifying things for the sake of brevity, but one can read much more in depth about these topics in my many books and translations, which I will list later on in the interview. The one that touches on the Jewish-Khazar topic specifically is *Parasite!*

To the point, the Jewish Exilarch at the time was Naim Dangoor. The Exilarch before him was Ezra Dangoor. These Iraqi Jews made their fortune from the liquid poison, Coca-Cola, prior to the rise of the Ba’ath Party, which ultimately forced the Dangoors to flee to the City of London where they connive and thrive behind the scenes to this day. The Dangoors, who are virtually unknown to the non-Jewish world, are at least as wealthy and politically influential as the Jewish Rothschilds (the UK, America and Europe), the Jewish Sassoons (India), and the Jewish Kadoories (China). I will talk more about these people later on in the interview, but the following is part and parcel of these Jews’ thinking:

*...Amschel and his children and most of his grandchildren thought of themselves as descendants of the ancient line of Jewish parnassim, lay leaders of the Jews who were responsible for the welfare of their brethren. It was their task, and duty, to protect them from their enemies. But the **Rothschilds considered themselves much grander; they were perhaps the descendants, if not literally then in spirit, of the Exilarchs, who led the Babylonian Jewish community 1,000 years before; and of such medieval figures as Don Isaac Abarbanel, treasurer of the kingdom of Portugal in the 1480s and tax farmer of Ferdinand and Isabella later that decade and who led the Jews into exile when they were expelled from Spain in 1492.***²⁰

3. When did you first become interested in history, and what led you to explore and focus about these topics?

I have always enjoyed history as a subject. But it was not until the late 90s that I started to develop an interest in Hitler as a subject. The first book I got was Robert Payne’s *The Life and Death of Adolf Hitler*, which I now look upon as printed garbage in the light of what I have learned about the man and National Socialism. But at the time, I just went to Barnes & Noble and found a book that seemed comprehensive, so I got it. I also purchased a copy of *Mein Kampf*, which was more or less “out of the blue,” as the saying goes. I can’t explain why I wanted to read it, but upon reflection, I think maybe it had to do with the terrible economy and degenerate society of America at the time. I think perhaps I was disillusioned by it all and I wanted to know what this guy had to say about things way back when. Again, I really can’t explain it, so maybe there’s some mysterious metaphysical aspect to my interest in the subject.

4. Basically, it never really ends, because you're not just "awakened"—if you keep pursuing your interest, it's been an endless process with many hidden aspects to discover. Has there been anything over time that has really surprised you?

Absolutely! The research of Doreen Dotan on the Jewish "Babylonian" family lines. As well, Sean Hross' research on Switzerland. And while I will not discuss it in this interview for fear of carrying on too long, the book *Adam Weishaupt: A Human Devil* is one of the most eye-opening books I've ever read on the Jews and Freemasons. In a nutshell, the author argues that the Bolshevik Revolution was a continuation of the French Revolution. They were not disparate revolutions but related actions that occurred along a specific trajectory. It is quite mind-blowing. I highly recommend it.

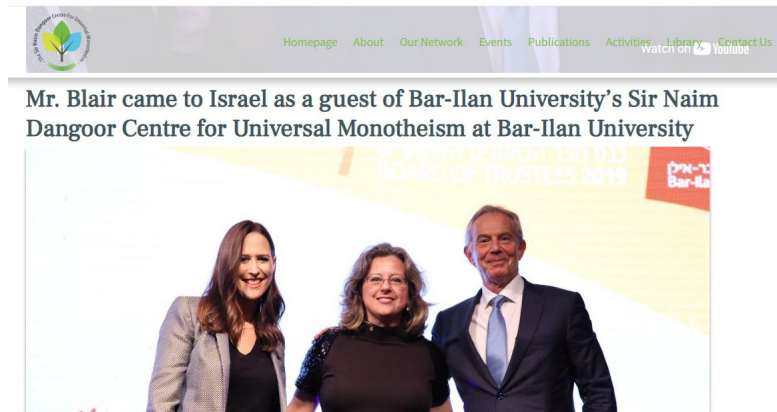
To begin, I was engrossed when first learning about the Jewish Dangoor family via Dotan's research, which today embodies the Babylonian Exile. As I wrote back in 2024, the Jewish Exilarchate did not disappear, contrary to mainstream information, but went "underground" to hide from the public eye. They exercise their power via "philanthropy," the "Green" Agenda (Agenda 2030, in particular), and via expansion of the state of Israel. They have been helping to create Greater Israel – or re-founding "Babylon" for themselves – through wars in the Middle East. They have effectively removed Syria and Iraq as threats to their expansionism, and now they are in the process of taking out Lebanon and Iran to finalize their plan. Indeed, the ultimate goal of these 'Babylonian Exile' families (*i.e.*, the Dangoors, the Kadoories, the Sassoons, and the Rothschilds) is to recreate what they believe is the original Jewish homeland. They are currently attempting to extend Israel's geographical and/or political borders all the way to Turkey and Iran. (Saddam Hussein had to be removed because the Ba'ath Party introduced anti-Jewish measures. That was when the Dangoors left Iraq for Britain.) Iraq is not to be an "Arab state"; it is, rather, to be a Jewish state (Iraq is still "Babylon" to these Talmudic-Babylonian Jews). As aforementioned, the Jewish Exilarch today is David Alan Ezra Dangoor and the Exilarch prior to him was his father, Naim Dangoor.

Which was church, and which was state? From the rabbis' perspective, it is clear that the exilarch was a merely political figure, but they were endowed with the sanctity deriving from Torah, revelation. So they would, in modern terms, have called themselves "the church," and the exilarch was "the state." And—"by me, kings rule." But the exilarch's viewpoint could not have conformed to theirs. So far as he was concerned, his rule was as the surrogate of the Messiah, indeed the best assurance that the Messiah would one day come—and would come from his own household. Israel was not rejected of God so long as she governed herself, and the exilarch's present rule was therefore proof of the continued validity of the covenant, of the enduring Messianic hope. The sceptre had *not* departed from Judah. The exilarch was *not* a secular authority. He claimed to descend from David, to be the link between the rule of David in the ideal past and the rule of David in the ideal future. The Torah-myth thus came into conflict with the Messiah-myth as the exilarch expounded it.

I think you and your readers will find the following excerpt, taken directly from the late Naim Dangoor's publication *The Scribe*, most revealing as to the former Exilarch's vile hatred for Germany and Germanness. I personally found this excerpt shocking, since Dangoor readily admits that Jews created the atomic bomb and were eager to use it. The article reveals the

profound obsession these Jews feel when it comes to their hoaxocide. The numbers they spout off and the comparisons they make, based on the most phantasmagorical death figures one could ever even hope to imagine, are truly something to behold. As a result of his fixation on the hoaxocide, Dangoor expresses a bizarre secret desire to drop as many nuclear weapons as Israel pleases on Germany, in the year 2000, to eliminate 6 million Germans in one fell swoop. Whenever I read of a national disaster which a number of people met their death, I ask myself how it compares with the Holocaust. Thus, when a recent earthquake killed 200 people, I worked out that it would take 30,000, yes thirty thousand such earthquakes to equal the Holocaust. Everytime I go to the Royal Albert Hall, next door, which seats 6000, I realize that that number of Jews were led to the gas ovens **every day** of the Final Solution, Jan '42-April '45.

The recent discovery of a mass grave of 3000 in war-torn Bosnia has shocked the world. Yet Holocaust is equivalent to 2000 of such mass killings.

Much fuss was made over the Hiroshima bomb which killed 30,000. Yet it would take 200, yes two hundred such atom bombs to kill the 6 million of the Holocaust.

The atom bomb was exclusively a Jewish device, planned, designed and produced by Jewish scientists and later chaired by Bernard Baruch. The pity is that it wasn't ready in time to drop on Hitler's head and his fellow Huns. You wicked Huns – you ought to be destroyed. "Worthy is he who will repay you in your coin. Worthy is he who will dash your babes against the rock."

Next up is Sean Hross. While Hross' research is imperfect, he nevertheless examines some fascinating lines of inquiry as far as the Swiss are concerned. I never really thought about why

all of the Zionist conferences were held in Switzerland up until the creation of the so-called “Jewish state” after World War II. As well, I had no idea that there was so much Masonic and Egyptian/pharaonic imagery incorporated into the architecture of Switzerland. It’s odd, to say the least.

Basel, Switzerland — *It’s one of the great wonders of the ancient world: the magnificent tomb of Pharaoh Seti I, the most elaborate and beautifully decorated in Egypt’s Valley of the Kings near Luxor. And in an extraordinary feat of modern technology, a specialist art company, Factum Foundation, has begun a five-year project to 3D-print a perfect copy of it. The eventual aim is to install it in Egypt on a site not far from the original.*

*...The man behind the project is Factum Foundation’s founder, Adam Lowe. He freely admits that Seti’s tomb is his obsession, calling it “the most important library of **Pharaonic religion, philosophy, art, poetry and science; the source material for the three Abrahamic religions**.”*²¹

Incidentally, Seti took his name after the Egyptian god Set, who became associated with disorder, and was increasingly demonized and linked to evil and foreign persecutors. His name and identity eventually became likened to Satan.²² Why *this* particular pharaoh, and why in Switzerland? It begs the question. If one tries to find information on the Egyptian imagery on Swiss buildings, one gets this obscenely childish answer from AI: “...the presence of Egyptian motifs in Switzerland can be attributed to the broader 19th-century Egyptian Revival architectural trend across Europe, as well as legitimate cultural exchanges and the presence of Egyptian artifacts in Swiss museums...”

Right. So, countless obelisks in Swiss-Jewish graveyards, Egyptian women depicted on public fountains, obelisks on bridges and roadways, owl and acorn obelisk capstones, all seeing eyes on police stations, and sun discs inside of Templar-era churches has nothing to do with Freemasonry and the people who actually rule Switzerland, and just about every other country in the civilized world today. These are all just 19th-century architectural “fashion statements”.

When one looks at the City of London, Washington, D.C., the Vatican, and Switzerland, one starts to notice interesting symbol patterns. For example, one will find architectural references to “as above, so below” in all of these cities. The Washington Monument comes to mind. It’s an obelisk with a reflecting pool, so that it appears the same above ground as it does “below ground”. The US was founded by Freemasons. This is a well-known fact. According to Hross, the name “America” has nothing to do with Amerigo Vespucci or even the Viking term, *Omme Rikka*. The name literally translates to: “*The reincarnation of the big pyramid will take place where our souls will live.*” *Ah* means “pregnant” or “big”; *me* (*Meru*) means “pyramid”; *ri* or *ra* is “sun”; and *ca* is “soul”. Hross also asserts, contrary to popular belief, that the Statue of Liberty, which is really Isis, was commissioned by a lodge located in Zollikofen, Switzerland at the Bernstrasse 116 Logenhaus. After Hross called them out in a YouTube video and filmed their placard on the building, they removed their name; though, the *other* lodge names remain on the placard and are listed as follows (according to an AI search on Brave):

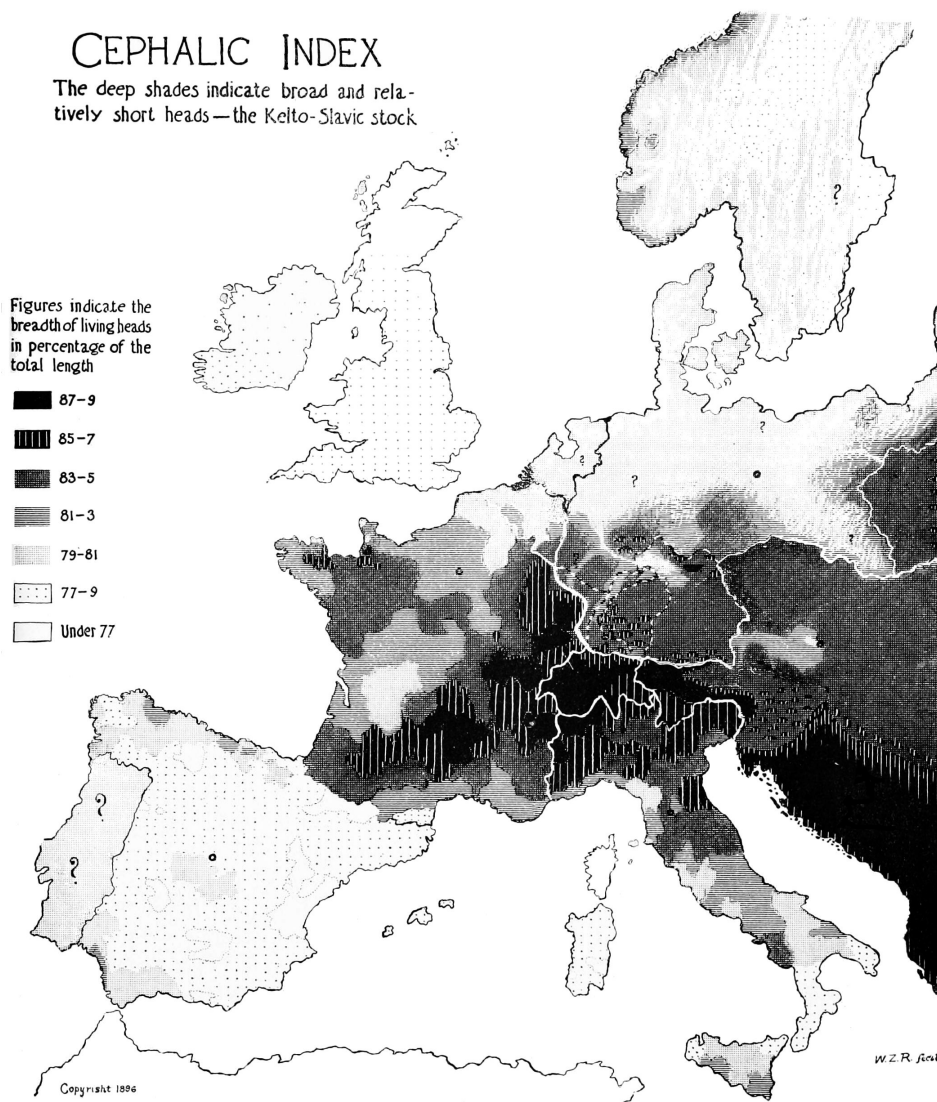
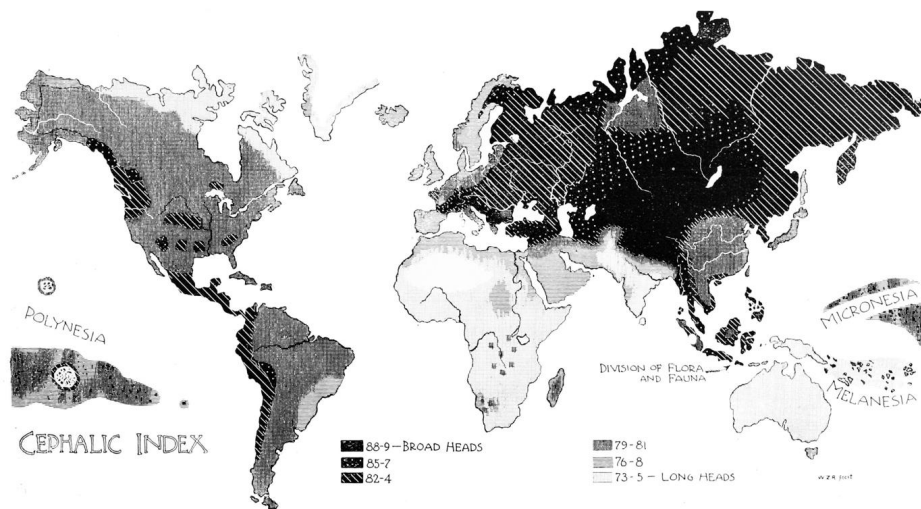

The Logenhaus at Bernstrasse 116, CH-3052 Zollikofen was the meeting venue for A.M.O.R.C. – Die Rosenkreuzer (the Rosicrucians), as listed on their German-language events page. The local A.M.O.R.C. group is called “Pronaos Ferdinand Hodler, Bern” — a “Pronaos” is the name A.M.O.R.C. gives to its local meeting bodies (the term comes from Greek temple architecture, meaning the front vestibule). The other names on the placard — Druidenorden (Order of Druids) and Niklaus Manuel Loge Bern (a Masonic lodge named after the 16th-century Bern artist and politician) — are consistent with a multi-tenant lodge building.

If the world’s most powerful and secretive elite are not all part of the same club (*i.e.*, Freemasonry), then why do we see the same Egyptian-Templar-Freemason imagery in so many different places throughout the world? One has to be ignorant or an imbecile to deny the international links. Switzerland, as Hross’ research suggests, plays a peculiar role in this power matrix and it always has had a peculiar role. Though, I should note that Hross completely excuses Zionism and attempts to paint the Nazis as part and parcel of the Swiss plot to destroy Europe. I have found more than enough evidence to counteract this claim, as I am sure you have too. Adolf Hitler opposed Freemasonry, Jews, the Vatican, secret societies, and any and all international fronts, such as *Esperanto*, *Masona*, etc. Hross makes the claims he does about the Nazis based solely on the Nazis’ use of the swastika and what he deems the “templar” cross (iron cross), but the adoption of these symbols was nothing more than a case of appropriation. Hross believes that the so-called “holocaust” actually happened and he blames the Nazis for World War II. I wonder what Hross thinks about the Zionists now that they have brazenly engaged in genocide and countless other crimes against humanity since October 7, 2023. We now know that Netanyahu had foreknowledge of the planned attack and ignored it.²³ He needed a credible pretext for his Gaza genocide and ethnic cleansing campaign against the Palestinians. It was perfect. *Cui bono*? Certainly not Hamas or Palestine. It will not shock me for a second if we come to discover that Mossad agents infiltrated Hamas and helped plan and carry out the attack. I would not put *anything* past the Jews. But I digress.

Coming back round to Switzerland, the Swiss were extremely aggressive and expansionist from the 13th to the 15th centuries. Hross claims that they are the brachycephalic descendants of the Mongols and Khazars, however there is little DNA evidence confirming this speculation. He bases his hypothesis solely on craniometry, which is not sufficient proof that the geographical origin of the Swiss was either Mongolia or Khazaria. What I did find interesting is that the Swiss are genetically divergent from the rest of Europe. As well, Hross is correct that they were predominantly brachycephalic, according to craniometry experts of the day. And Hross cited a certain cephalic index map that proves there was a very high concentration of brachycephaly in Mongolia and the area now known as Switzerland, as to be found in Coon’s research.

It's an interesting observation and perhaps Hross is onto something when he suggests that the ancestors of the modern Swiss were aggressors who effectively invaded an otherwise peaceful

Europe. For centuries, the Swiss were known as ruthless mercenaries for hire and most other Europeans feared them in battle. But one cannot definitively say that the Swiss are a “*different species*,” from the rest of Europe, as Hross has done. They do have steppe ancestry, but this is not necessarily Asiatic.²⁴ While Switzerland collectively constitutes a diabolical state and people – playing host to the Bank for International Settlements (the central bank for central banks), the so-called “Geneva Conventions,” and every single Zionist Congress up until the creation of Israel – they are not as genetically or racially uniform as Hross suggests. And any researcher who ignores or excuses Talmudic Judaism and/or Zionism cannot be trusted. Hross does both. He is always endorsing the hoaxocide and making excuses for the Jews.

As for the Ashkenazi Jews, they are not a simple, straightforward continuation of the Khazars, as Hross claims. It is a bit more complicated than that, which I have included in my book *Parasite!* Contrary to earlier studies published in 2013 by Jewish researchers, which disclaim much, if any, Khazarian contribution to the Ashkenazi Jews, more recent studies affirm stronger ties.

*...an alternative theory proposed by Professor Paul Wexler from the University of Tel Aviv and also an author on the study, ...published today (Wednesday 20 April 2016) in Genome Biology and Evolution, led researchers to believe that towards the end of the first millennium, Ashkenazic Jews may have relocated to Khazaria before moving into Europe half a millennium later after the fall of the Khazarian Empire, and during a time when the international trading networks collapsed.*²⁵

If Ashkenazi Jews lived among the Khazars, then they mixed with them, too. And this has, in fact, been validated by more recent research findings published in 2018. What’s more, given that Ashkenazi DNA is more representative of European genetics than those of the Middle East, they have no claim whatsoever to the land currently inhabited by Palestinian Arabs.

*...~40% of Ashkenazi mtDNA variation, have ancestry in prehistoric Europe, rather than the Near East or Caucasus. Furthermore, most of the remaining minor founders share a **similar deep European ancestry**. Thus the great majority of Ashkenazi maternal lineages were not brought from the Levant, as commonly supposed, nor recruited in the Caucasus, as sometimes suggested, **but assimilated within Europe**...*²⁶

The behavior of the Ashkenazi rulers of Israel today is worse than abhorrent. It is demonic.

Moving along, I have also found the research on Swiss “crypto-Jews” rather interesting. I discovered that many Swiss families share significant DNA with a variety of Jews, including Mizrahi, Sephardic and Ashkenazi. There are two excellent websites dedicated to research on the Swiss and many other crypto-Jewish lineages.²⁷ The Jews can no longer shriek about

“conspiracy theories” when non-Jews bring up the crypto-Jewish phenomenon. It’s real and a verifiable fact that crypto-Jews exist. And, more than likely, their DNA guides these crypto-Jews’ behavior whether they realize it or not.

I would definitely encourage you and your readers to hear and read what Sean Hross has to say because he has a lot of valuable insight to offer despite the shortcomings of his research. While it’s debatable whether the Templars actually founded modern Switzerland in 1291, it is true that the Templars owned estates, churches, houses and financial interests across Europe, including in modern Switzerland. Their presence was particularly associated with Geneva, Lausanne, Fribourg and the western Swiss region. This is notable, especially since Masonic and Templar imagery and symbols can be found all over Switzerland. One Jewish cemetery, in particular, is literally riddled with obelisks, so a Masonic-Swiss-Jewish connection is undeniable. On top of that, we have the assertion by some researchers (Fritz Springmeier, for example) that the BIS was founded by the Rothschild Jews. I never would have looked into Switzerland or the BIS had it not been for Hross’ research. I also would not have known about Swiss child slavery. It’s unreal to me that the Swiss authorities kidnapped children and enslaved them for decades. We are talking about an estimated 100,000 children. Switzerland practiced a state-sanctioned system of indentured child labor known as *Verdingkinder* (contract children) from the 19th century until 1981.

*Tens of thousands of children, primarily from poor, unmarried, or marginalized families, were forcibly removed by authorities and placed with farmers or factory owners who paid for their labor. These children were often treated as commodities, with some even sold at public auctions, and many suffered severe physical and sexual abuse, neglect, and forced labor well into the 20th century.*²⁸

Switzerland should definitely be on the same list as Israel. The BIS is effectively a pawn of Jewish banking and Switzerland lets it operate with no oversight or accountability. The BIS offers zero transparency to anyone, whether state or agency. It is completely sovereign. While the BIS was not founded by the Rothschild clan per se, Rothschild bankers had extensive relationships with European governments and central banks, and Rothschild banking interests were deeply embedded in international finance. As such, they can justifiably be considered synonymous with the BIS.

5. “If you don’t know anything, you have to believe everything!” - And that’s the problem with a lot of people. Well, this has been the case for decades now that everything evil and bad is compared to either Hitler, the Third Reich, or to National Socialism. And yet it still works; many people believe the whole fairy tales.

How do you react, for example, when someone argues that a current politician been compared to Adolf Hitler, or the EU to the Third Reich and National Socialism, or when people even label the new surveillance possibilities with the phrase “1933 comes to mind”?

Honestly, I have to ignore it. Unfortunately, the average person is now so dumbed-down with the advent of Jewish AI along with all of the other Jewish-controlled media outlets that debating them is futile. Personally, I think Jewish AI is being intentionally deployed to control information. Eventually, AI will be our only source of information and all independent research and thinking will be illegal or impossible. Such was the case back in the early days of the Church. Think about it. The only knowledge people had was the Bible. That was literally the only information anyone knew and that was deliberate on the part of the Church. People were more easily controlled when that was all they knew. It was not until the Jewish “Enlightenment” and the rise of Freemasonry and its Illuminism counterpart in France that things changed. All of a sudden, the Jews were pulling people away from the Church with laicism²⁹, reason, humanitarianism, and progressivism. Such will be the case with AI today. The dumber people get and the less they do on their own, the more easily they will be controlled and lulled into a UBI system. It’s scary.

I guess the one thing I would say about Hitler and National Socialism is this: Hitler was the only politician I have ever come across who cared about his people in the deepest sense of the word. When a person cares about your genes and does everything in his power to protect your genes and heritage, that person is a unicorn. It’s as simple as that. We have never had a politician like him before or since. Regardless of his flaws, the man cared about Germanness and securing a future for what I consider one of the single most valuable races/groups of people in human history. The contributions of the Germans are immeasurable. And last I checked, the Nazis were never accused of wantonly targeting children in neighboring states, not even Jewish children. The Jewish hoax aside, Hitler waged a very clean war for his time. The Jews, on the other hand, are blatantly engaging in ethnic cleansing and genocide in the year 2026, when liberalism and humanitarianism is allegedly “all the rage.” The only question I had to ask myself back when I first realized that the Jewish hoax was indeed a hoax is a very simple one: who in their right mind has a hospital and allows births in a death camp? That is the single stupidest thing I have ever heard in my life and it has really stuck with me. Death camps do not have hospitals, social gatherings, performances, art, libraries, and Red Cross visits. Anyone who still believes the Jewish hoax ought to be ashamed of him- or herself. Seriously. I would also remind people that before there was Israel, there was World Jewry. The Jewish collective acted exactly the same in Hitler’s day as they do in modern Israel. They were just as criminal, genocidal, warmongering, and troublemaking then as the Israelis are today. The only differences between then and now are that now they have a physical state and an army of their own. In Hitler’s day, they were still a state, just without borders. And they used the armies of the world to fight their wars for them. Now that they fight for themselves with their own soldiers, we can see how criminal and genocidal they are. The entire world is finally seeing how the Jews act when they are in power; do we really believe anything has changed since Hitler’s day? And yet, we still hear the same childish nonsense, like Hitler hated Jews because he was jealous of them. Or, Hitler used the Jews as a scapegoat for Germany’s

7. Your "Black Nazis" book series is probably your best-known work to date, isn't it?

Black Nazis is my most well-known book, since it had the most marketing exposure. It is not a series, but a single book that is currently in its third edition. It was originally offered via Amazon, so it had notable reach. I sold copies to prominent authors and researchers, such as the late Robert Faurisson (French holocaust revisionist) and Antonio J. Muñoz (Axis Europa publisher). It was my first publication, released in 2009 as a paperback after I graduated from Norwich University.

The first print run consisted of just 100 copies, many of which were signed. The second and final print run consisted of 100 stamped "Vera Icona Reprint" copies. Thus, there are only 200 total copies of the first edition paperback in the world. The first companion book to *Black Nazis*, entitled *Hitler's Most Significant Speech: The Fuehrer Addresses Officers and Generals at Platterhof*, was limited to 300 paperback copies, of which several were signed. That edition is out of print and has been since 2009. A paperback "Collector's Edition" of *Hitler's Most Significant Speech* was available on Amazon before it was banned and it was limited to 100 total copies, of which only about 30 were ever printed. So, that edition is extremely rare. *Hitler's Most Significant Speech* is currently available as a hardcover "Collector's Edition," and is also limited to 100 copies. Only about 25 have been sold thus far, so that one is still available.

I released two different second editions of *Black Nazis* (both entitled *Black Nazis II: Ethnic Minorities and Foreigners in Hitler's Armed Forces - An Unbiased History*) between the years 2010 to 2015. These second editions had a lot more information and photos than the first edition. The two second editions have different cover art from one another. Furthermore, the second print run of the second edition had even more information and photos added after the first release of the second edition. So, the second print run was an expansion upon the first print run of the second edition. The subsequent third edition, first released in 2016 and revised several times since then to accommodate my newest findings, has quite a bit more information

and photos than either of the second editions. It is currently available in hardcover format under the title: *Black Nazis III: Ethnic Minorities and Foreigners in Hitler's Reich*.

8. Your books are now available through “Wilk Mocy Publishers” (www.wilkmocypublishers.com). Have you encountered any censorship-related issues in the past regarding the publication and distribution of your books?

Yes. A few of my books were initially banned by CreateSpace before CreateSpace was superseded by Amazon's KDP (Kindle Direct Publishing). Amazon suddenly decided to shut down CreateSpace, which forced me to rely on KDP. I was able to publish for a few years via KDP, but then 'out of the blue' my account was terminated and no explanation was ever provided. That happened shortly after all books related to holocaust revisionism were banned on Amazon and by KDP. My books were also banned by another publisher, but I cannot disclose the details of that particular termination. That one was also 'out of the blue' with no explanation provided. My account simply disappeared one day. I cannot advertise or sell my books anywhere that is considered “mainstream” owing to Jewish censorship.

As well, the first Wilk Mocy Publishers WordPress website was terminated owing to Jewish complaints to WordPress. I had to seek out an alternative free-speech hosting company to get back online.

9. Some of your books, especially your earlier publications, feature images related to wolves. Do these have any symbolic meaning?

My initial reason for the wolves on the covers was to help prevent censorship of my books. Of course, the wolves also have symbolic meaning in the sense that the Germans used several wolf references during the National Socialist years. For example, there was Hitler's *Wolfsschanze* (Wolf's Lair) and the *Werwolf* (Werewolf) resistance movement at the end of World War II. Anyone who researches the name Adolf will discover its true meaning, which might also have something to do with a wolf. Wilk Mocy is Power Wolf in Polish.

Another reason I chose the wolf and other animals for the covers was to capture an *Animal Farm* feel. George Orwell's book is a powerful one and it had a significant impact on me. The hyenas represent the Jews, of course, and the jackals represent the British. I got the hyena idea from the clever artwork of John Heartfield, as seen here:



And the jackal was a perfect pun on the British Union Jack. Hence, my book *The Union Jackal*, which is a scholarly condemnation of Britain, British policy, and the British people. The black and white wolves juxtaposed on a couple of the covers represent different races, such as black and white (e.g., the cover of *Nation & Race* and *Swastika & Scimitar: Brothers in Arms*).

10. A quote from “The American Hebrew” from 20 September 1920:

“What Jewish idealism and Jewish discontent have so powerfully contributed to produce in Russia, the same historic qualities of the Jewish mind are tending to promote in other countries....The Bolshevik revolution in Russia was the work of Jewish brains, of Jewish dissatisfaction, of Jewish planning, whose goal is to create a new order in the world. What was performed in so excellent a way in Russia, thanks to Jewish brains, and because of Jewish dissatisfaction and by Jewish planning, shall also, through the same Jewish mental and physical forces, become a reality all over the world.”

One of many quotes and references that in retrospective can be seen as pointing to certain global structures shaping world history and the formation of societies. When one considers past events, crises, wars, as well as the re-education measures imposed on societies around the world up to the present day, and recognizes the connections and relationships, one comes to the realization that these particular quotes from certain older literature were indeed true.

How do you view global development and current world events?

We are on a path to world Jewish supremacy in both mind and deed. If one is to look back on the people who instigated the multiple wars in Iraq, the war in Afghanistan, the war in Libya, the multiple wars in Syria and Lebanon, then one would notice a common denominator. And that would be Jews. And to those who still believe that there’s a measurable distinction between Jewishness and Zionism, I would only point to studies that reveal how much American Jews support Israel, whether politically, monetarily, or in other ways.

According to the Jews themselves, 63% described themselves as pro-Israel:

- 32% — *pro-Israel and critical of some Israeli policies*
- 31% — *pro-Israel and critical of many Israeli policies*
- 23% — *pro-Israel and supportive of Israeli policies*
- 9% — *not generally pro-Israel*
- 5% — *unsure/no view*

Approximately 85–90% of American Jews support Israel’s existence, and/or identify as pro-Israel, while roughly 20-30% support the Israeli government’s policies without reservations.³⁰

So, whether openly Zionist or not, the majority of Jews support Israel. And very, very few stand up against Israeli policy. I have personally had to change my own view in this regard, as I also used to believe there was a distinction. There isn’t. Israel is an evil nation and the Jewish people will never get along with their Arab neighbors. That isn’t the goal of their leaders anyway. The goal of the powerbroker Jewish families – the Dangoors, Rothschilds,

Kadoories, Sassoons, etc. – is the recreation of Babylon in the form of Greater Israel (see the 1996 Clean Break report). They will not stop until that is achieved.

As for Jewish leaders and companies living amongst us non-Jews, they will continue to systematically destroy us with AI—Dario Amodei, Mark Zuckerberg, Sam Altman, Sergey Brin, Larry Page and Demis Hassabis are all Jews.

*Research indicates that **Jewish Americans are overrepresented by a factor of two to six-and-a-half** in the intellectual property used to train large language models (LLMs), despite comprising only about 0.2% of the global population. This disparity, described as a ‘canary in the AI coal mine,’ means that **AI systems disproportionately rely on Jewish-authored content...***³¹

And now that the US has crossed the \$40 trillion debt threshold, the Jews will implode the US economy and then buy up anything and everything they can for pennies on the dollar when the crash happens. Personally, I think they are planning a crash. They want it to fall. They will be unaffected by a collapse just as they were unaffected by the crash of 1929 and the Great Depression. The Jewish elite were living ‘high on the hog’ while every nation suffered their global financial chicanery. The coming crash will be the same Jewish financial manipulation, but on a grander and far more destructive scale.

Jews are statistically overrepresented among the world’s billionaires, with estimates suggesting they comprise approximately 10% to 11.6% of the global billionaire population despite making up only about 0.2% of the world’s total population. This represents an overrepresentation of roughly 50 to 55 times their share of the global population.³²

I believe they want a collapse so that they can fulfill their collective dream of a one world government. The surveillance state is already being erected and the control mechanisms are being introduced. We are being recorded and tracked by our motor vehicles. We are being surveilled by Flock and CCTV cameras. We are being systematically forced into renting and non-ownership with ever-increasing insurance premiums, property taxes, forced subscriptions, and technological advances (e.g., robotaxis). This reminds me of that article published on the *World Economic Forum* website entitled, “You’ll Own Nothing and You’ll Be Happy.” Since that publication, an AI economy, social credit systems, and UBI are being seriously discussed as viable solutions to our (Jewish created) problems. And then we have increasing security measures being introduced all the way down to the micro-level. Third party biometric authenticators and implantable microchips are becoming more common and more acceptable to the average person. The ruling elite are slowly pilfering what little freedoms and sovereignty we have left. I really do fear for the future.
