

Thank you for responding to my request for your books. I'm trying to understand the roots beneath what I believe is the most significant situation going on in the world today due to the historical affect of Zionism and its future potential.

At the root of Zionism, you will find two very important pillars: the “Chosen People” principle and the holocaust narrative. The Zionist Jews believe that they have an inherent right to establish a state of their own in the region formerly known as Palestine. This inherent right comes directly from Yahweh, who told the Jews that they will be blessed as rulers of the world – so long as they keep their covenant with him, Yahweh. The holocaust narrative created – and continues to perpetuate – the global sympathy necessary to establish and maintain this “right” to the “Holy land.” I recommend *Moloch-Yahweh*, *Albion & Zion United*, and *The Hyenas of High Finance*, in this regard.

Many Traditional Religious Jewish People are at odds with many Zionist Jews, Zionist Christians and Zionist Atheists (collectively) - and now particularly over the ongoing unprecedented slaughter in Israel. Both sides reference Hitler and the Holocaust. So I'm seeking to separate traditional religious Jewish People and the Zionists both before the Holocaust and afterward. From what I have learned about Traditional Jewish People (the authentic religious Jewish People - I cannot understand why anyone would want to hurt them. I have not found that they were bothering anyone and I have not found prejudice or greed, etc. to be within their practice. But then the Zionist "ethnic" Jews (as they consider themselves) along with Christian Zionists and Atheist Zionists collectively raised lots of Hell since Zionism took hold in the 1940s (if this was the initial time-frame).

Zionism begins with Theodore Herzl, but Zionism in practice did not really take off until the 1930s to 1940s, so you're correct about that. It sounds to me like you are differentiating the Middle East Jews (Mizrahi, Sephardic) from the Ashkenazi Jews, which is a good starting point.¹ The Middle East Jews are genuinely Semitic people who can trace the majority of their DNA to the Middle East region. This rule also applies, perhaps a bit less so, to the Marrano Jews of Spain. (Rumor has it Christopher Columbus was a Marrano.) The Middle East Jews have lived in relative peace with the other Semitic peoples in the region for decades prior to the arrival of hordes of Ashkenazim to Palestine during and after World War II. The Ashkenazim, who are in fact Ashina-Khazars from Eastern Europe, are the “Zionist ‘ethnic’ Jews” to which you are referring. They are the foremost cause of today’s ME conflict.

¹ Sephardic (Greek and Turkish), Ashkenazi (Eastern European) and Mizrahi (Iranian, Iraqi and Syrian) Jews...originated in Europe and the Middle East...Two of the major Jewish populations—Middle Eastern and European Jews—were found to have diverged from each other approximately 2,500 years ago.

I've not been able to find answers in bookstores - except that Adolph Hitler was evil. No real analysis of his writings or his specific actions - and no effort to match the two, and no effort to deconstruct his administrative personnel in a similar manner. Most of what is available appears to begin with a conclusion and then lots of name-calling and opinion - but not the substantive, verifiable fact and analysis one should expect. I'm looking for substantive analysis and verified facts about him. If his writings were readily available - this would help people form their own opinions.

You are right to purchase *Mein Kampf* and just go straight to the source. It is such an amazing compendium, though keep in mind that it had an estimated 12 editors and possibly other contributors, such as Rudolph Hess. So, it may not be 100% Hitler. That said, I remember thinking the following before reading MK and learning all I could about Hitler: Hitler killed people for some inexplicable reason, I want to understand why. Why did Hitler hate the Jews? What was the basis for that? This was the first major question I asked and it's similar to yours.

Along with MK, I recommend *Hitler's Most Significant Speech* and *The Essential Hitler*, in this regard.

My questions include the following: Why did Adolph Hitler want to kill people - what was his objective? Land? Resources? Behavior?

Hitler never *wanted* to kill people; he did not enjoy the suffering of others. Footage of collateral damage upset him immensely and he would refuse to watch it or view the carnage in person. It just so happens that killing some people and groups became a necessary evil to achieve his goals. Political opponents and wartime traitors and partisans were the main targets. Jews were never killed simply because they were Jewish. The Jews who were deliberately killed by NS authorities were engaging in some sort of traitorous or communist activity. As for the rest, there were an unknown number of Jews and other persons who perished in the concentration camps, but the reasons for their deaths are wide-ranging. The only way to get one's head around this topic is to read everything there is to read about the camps and the holocaust story, which is available from CODOH: <https://armreg.co.uk/>

If behavior - what behavior and who specifically was doing the behavior (for example - if it was Jewish People was it all Jewish People - or just the people to become the Zionists - and then who else?)

The specific behavior, in most cases, was communist or traitorous activity. Just as the current US administration under Biden has defined what treason looks like – the January 6th capitol gathering, for example – so, too, did the NSDAP define what treason looked like in Germany at the time.

There were three groups of Jews that earned Hitler's ire: the high finance Jews (e.g., Paul Silverberg), the political Jews (e.g., the "November Criminals," such as Walt Rathenau) and the communist/anarchist/SPD Jews, such as those who tried to declare Bavaria an independent Communist Socialist Republic (e.g., Emma Goldman). The high finance Jews were seen as exploiters of the German people. When Hitler was appointed chancellor, these Jews transferred all their wealth abroad, to avoid paying taxes, etc. under the incoming Hitler government. Hitler did not appreciate that for obvious reasons. The political Jews were responsible for Germany's acceptance of the Versailles Treaty as well as the complete collapse of the mark (resulting in unparalleled hyperinflation). The communist/anarchist/SPD Jews were seen as agitators against the authorities and Soviet fifth-columnists. These views were based on intelligence, observation, and experience. So, the idea that these Jewish groups were simply scapegoated for no reason is baseless. Jewish intellectuals are in fact responsible for the scapegoat theory to begin with, so of course they use this against all their enemies. It's a very effective negation tool to use against one's opponent. The term *scapegoat* comes from the Jewish Book of Leviticus, wherein a goat was sent into the desert carrying the sins of the community.

I recommend *The Union Jackal*, in this regard.

What was the behavior - who did it affect and how? Whose behavior was targeted specifically? What were they doing - and were their activities "bad", and how did their activities affect the people who supported Adolph Hitler and for how long? Why were they doing this behavior they were accused of - if they were doing such behavior? What evidence did Adolph Hitler provide to his population to gain their support? Who were his supporters in Germany and abroad (Elite people? Working class? Poor? Ethnic? Were there Jewish supporters of Hitler or were they Zionist? Of what industries primarily beside automotive and banking?)

You will find answers to these questions above in *Managing Our Perception of the Third Reich*, *The 'Other' Nazis*, *Truth for Germany*, *The Union Jackal* and *Black Nazis III*. The Zionists were overwhelmingly supported by the

NSDAP because they shared a common goal with Hitler: the removal of Jews from Germany. The Zionists ultimately blackmailed Hitler into supporting Jewish emigration to Palestine, in particular, by promising to circumvent the Jewish worldwide boycott declared against “Hitler-Germany”. The boycott declared against Germany by “World Jewry” played a huge role in how Hitler and the NSDAP judged the Jews as a whole from early on. Ingrid Weckert’s *Jewish Emigration from the Third Reich* and her other book, *Flashpoint!*, are both essential to understanding the NSDAP’s approach to the various groups of Jews. German Jews rejected the global boycott while the Jews in America demanded an end to “Hitler-Germany.” So, not all Jews were viewed as the same. They were approached differently by Hitler and the regime depending on their political, financial, and social behavior. Again, answering these questions has taken me years and years of reading, since 2002/2003 to the present. It is not something you will understand in weeks or months.

What was Adolph Hitler's proven method of killing people and why did he select that method?

When Hitler was asked about punishment to be handed down to especially harmful traitors and would be assassins, he generally insisted that the guillotine or death by hanging was a fitting punishment. But mostly, traitors and such were simply shot by the Gestapo or SD. Torture methods were employed against would be assassins, but not ordinary people. Families were always provided for when traitorous generals or other persons were involved in treason. I highly recommend the Gellately books for details.

Or else how did the people die - and did Britain have a hand in the mass deaths?

Britian and America played a huge role in civilian and concentration camp deaths. The aerial bombing of Germany day and night in the latter half of the war had an incalculable role in concentration camp deaths. The near- or complete collapse of statewide infrastructure prevented vital food, medical, and other supplies from reaching many of the camps in a timely manner. How many people died and what percentages ethnically? Was one group of people targeted (say Zionists) and other groups (say Religious Jewish People) just caught up in the situation - or vice versa? Did mass bombing kill most people and by who?

I already answered these questions above.

What peoples were placed in concentration camps and why? What happened in the concentration camps? What was the point of the gas chambers verses just shooting people - why the expense of building them?

The main groups in the camps were pedophiles, homosexual men, Freemasons, communists, SPD socialists, political opponents, traitors, would be assassins, war criminals, civilian criminals, and POWs of all enemy nations. No single ethnic group, other than Jews, was targeted for incarceration. The Jews were gathered in order to be eventually deported to an area outside the Reich after the war was over. One must read the holocaust handbook series books on the camps to understand the dynamics of what happened in them. They were all different. Some had no guards and others had numerous guards. Some were quite livable and free and others were filthy and oppressive. It depended on the time in question (1934 or 1945), how much oversight there was, and who was in charge. Camps where communists were held had some of the highest death rates and abuses – mostly prisoner on prisoner murder and abuse.

The only gas chamber that existed after the war was a Soviet reconstruction. The shower heads that were in that reconstruction had no piping to them, so they were simply an ornamental fixture added by the Soviets. As such, there is no evidence that there were chambers used to gas hundreds or thousands of people at a time. David Cole, a Jewish revisionist historian, exposed the fake gas chamber decades ago and nearly lost his life for doing so. He spent years in hiding until he was outed by an ex-girlfriend. Who constructed the gas chambers (name or company) and were any gas chamber building plans found?

The USSR constructed a gas chamber after the war. They claimed it was a genuine, unadulterated reconstruction. But this is a lie. The original, Auschwitz-Birkenau plans do not show a gas chamber or chambers designed for killing people. The only use of gas that is substantiated by forensic evidence and is well documented by the Germans themselves was for delousing. The “chambers” were actually relatively small autoclaves where clothing and other items were placed and “gassed” with Zyklon-B tablets (there were autoclaves and a morgue at Ellis Island, as well). This eliminated the disease threats in the camps, notably typhus from fleas. The US used Zyklon-B for the same purpose:

The crematoria were present in some of the camps for corpse incineration. Cremation was more sanitary than burial. There was a crematorium at Ellis Island in New York for the same purpose – to incinerate any incoming

immigrants who happened to die while awaiting processing at Ellis Island. This was not some secret evil, but a necessary measure owing to potential for disease spread and to prevent nearby groundwater contamination (which human bodies will contaminate if buried in large enough numbers in a concentrated area).

What gas was used in the chambers? What did Adolph Hitler say in his own words that is most significant in our understanding his fears or aims? What did he write that can be referenced - and why is it hard to find text and quotes from him?

Hitler did not write much. He dictated MK in prison and wrote some letters and notes during World War I and in the 1920s. Otherwise, he didn't write. The best way to get an understanding of what Hitler thought is to read his numerous speeches. I would also recommend reading Heiber and Glantz's book on the wartime minutes (Hitler verbatim):
