We're going to examine two pieces of evidence which serve to exonerate the Nazis of the extermination claim. We are not experts in Hoax revisionism, unlike individuals such as Germar Rudolf and Arthur Butz, but we are capable of applying basic reasoning and common sense to evidence that is presented before us. In this post, we're going to look at two pieces of evidence in particular. But, before we begin, we are going to reiterate that the Jews bear the burden of proof regarding "extermination" during World War II, not the Germans. The Jews are the prosecution. And, frankly, the prosecution failed to prove their case at the IMT and NMT; hence, the birth of Hoax Revisionism beginning with Paul Rassinier.

Dear Mr. McClelland :

In reply to your letter of November 17, in which you asked us if a delegate of the International Committee of the Red Cross had succeeded in visiting the camp at Auschwitz, we are able to supply you with the following information :

It is a fact that one of our delegates was able to enter this camp. He approached the Commandant with a view to arranging a scheme of possible relief consignments for the civilian prisoners there. According to his impression, the camp was a type of "extensive concentration camp" where the detainees were compelled to do various kinds of work, including work outside the camp. Our delegate told us that he had not been able to discover any trace of installations for exterminating civilian prisoners. This fact corroborates a report which we had already received from other sources, i.e., that for several months past there had been no further exterminations at Auschwitz. At all events, this is not a camp containing exclusively Jews.

We are supplying you with this information personally and confidentially, because we obviously do not wish to publish the fact that this visit had been made. If it became known amongst the public, it might create the impression that the International Committee had means at their disposal of intervening in behalf of the detainees of this camp. Moreover, the Detaining Authorities might be tempted to assert that this visit by a delegate of the

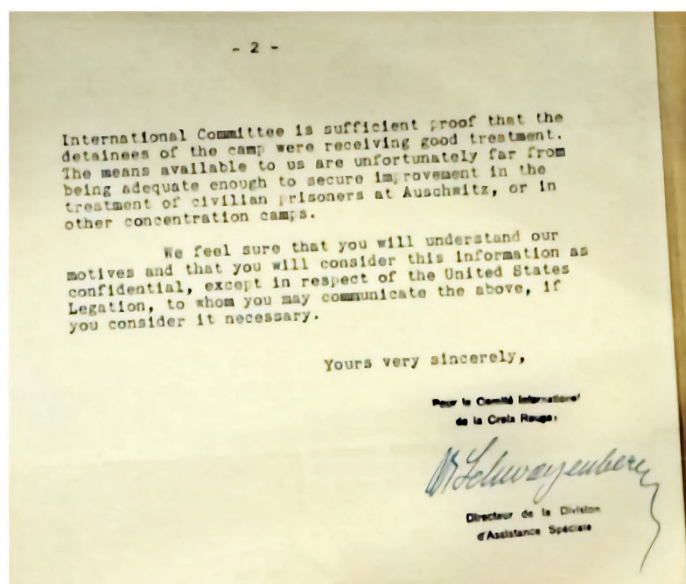
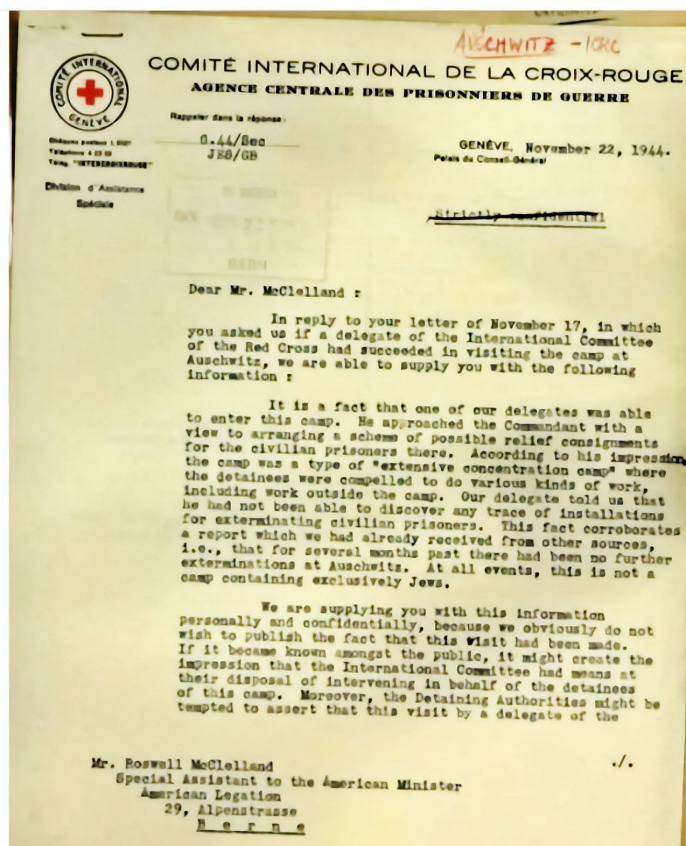

Conclusion #1: The Red Cross delegate was unable to confirm "extermination" facilities at Auschwitz in November 1944.

Conclusion #2: The Red Cross representative informs Roswell McClelland that his delegate's "on the ground" finding corroborates reports that had been received up to this time from *other* sources — sources which were obviously not credible thus necessitating McClelland's inquiry to the Red Cross in the first place — confirming that "no *further* exterminations" were taking place at Auschwitz. In fact, exterminations *never* took place at Auschwitz. These "other sources" were not believed by the Zionists, Allies, Vatican, etc., so, again: McClelland inquired to confirm that so-called "exterminations" were nothing more than Jewish/Polish wartime rumors (nearly all claims of alleged "exterminations" come from Polish and Jewish wartime sources). As such, this is an important anecdotal document insofar as it negates the Jewish "extermination" claims. When we combine this evidence with two other pieces of evidence: 1) the Soviets reconstructed the alleged Auschwitz "gas chamber" after the war,^{[1](#)} and 2) the IMT and NMT extermination claims were upheld solely by eyewitness testimony^{[2](#)} and confessions^{[3](#)}, then we can reasonably conclude that the prosecution's case is at best shaky, and at worst, a Jewish-Allied conspiracy.

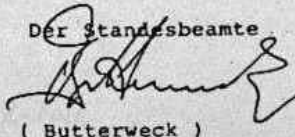

Jewish translation submitted to J.A. on X:

“The certification numbers do not allow for any conclusions about the actual numbers of the dead in the concentration camps.”

This means that one can’t conclude anything at all from this. So what was the point of painstakingly gathering these data for historians and the public? Just a meaningless exercise in Teutonic ‘dumb-dumb’?

The above translation is incorrect.

Correct translation (yes, it makes a big difference):

“The certification numbers of the Special Registry Office do not allow conclusions to be drawn about the actual number of deaths in the concentration camps.”

All the above is saying is that the Arolsen office does not allow conclusions to be made (deduced) regarding actual numbers of deaths in the KZs. The report does not say or even imply that these figures are inaccurate; the office is merely covering its ‘assets’: They are concerned that these figures may not reflect *all* KZ deaths, as some deaths could *possibly* have been *unrecorded* for *any number of reasons*. They don’t want you walking away from this document with the idea that it is definitive (e.g., maybe more deaths could be discovered in future; doc is from 1983). Fact is: these are actual, verifiable, confirmed KZ deaths for all KZs during the war as of 1983.

And this leads us to our final conclusion, having read Arthur Butz’s *The Hoax of the Twentieth Century* and Germar Rudolf’s *The Rudolf Report*: these Arolsen numbers *are* more or less *definitive*. The Arolsen archive was careful not to provoke Jews with these numbers, so they ruled them inconclusive. A conservative statistical analysis reveals that 537,065 Jews were still alive in May 1945, if 245,000 are still alive as of January 23, 2024⁴,

assuming a constant 1% annual mortality rate (based on an initial population figure of 6 million before the war broke out in 1939). Germany had approximately 565,000 Jews. So, as Butz concludes, nearly all alleged Hoax deaths were non-German Jews. Convenient, no? This is why the Jews are “missing” from the Arolsen data: because the alleged 6 million were from Poland, the USSR, Hungary, etc., etc. Since the postwar Jewish population problem was/is a complicated one for a variety of reasons, which Butz explains and accounts for, we won’t get into that here. There’s no need; Butz has done it already. Suffice it to say that the “missing” Jews were still alive upon war’s end. They never “went missing” in the first place; hence, the “*we all went up in smoke*” thesis. Jewish bodies and/or remnants of bodies were never found, and will never be found⁵, for the simple reason that they don’t exist. The Jews overwhelmingly survived the war and this is precisely why the IMT and NMT relied exclusively on confessions and eyewitness testimony to “prove” the Hoax.

Most extermination camp gas chambers were DISMANTLED OR DESTROYED in the last months of World War II as Soviet troops approached, except for those at Dachau, Sachsenhausen and Majdanek [ALL 3 OF THESE ARE DEBUNKED].
